


Family Engagement

While EPATT is widely known for our direct service work with youth, in fact, a significant amount of staff time is devoted to parents. We host mandatory quarterly workshops and, upon request, we accompany parents to school meetings. Families and staff regularly communicate with each other about their student's progress at school and at EPATT.

Tennis

Tennis provides an active and healthy outlet for our students. It teaches them about self-discipline, hard work and leadership and helps build self-esteem, confidence and feelings of self-worth. EPATT also has a tournament team for those who wish to compete in USTA tournaments.




