LETTER FROM THE EXECUTIVE DIRECTOR

Thirty years ago, East Palo Alto was a city ravaged by crime and violence. Under-funded schools were under-performing, and EPA students were being denied the education they deserved. Jeff Arons had a plan: to teach local kids tennis and provide them with supplemental academic support. This unique combination has been positively impacting East Palo Alto youth ever since.

At first, the goal was simply to get kids to turn in their homework. Before long, however, our goals – and the program – grew more ambitious. We set our sights on raising our students' high school graduation rate and helping them apply to and attend college. So, while some may still view EPATT as "that tennis program," our true calling has been helping students aspire to and attain the best possible future. It wasn't long before we became a national model for other youth education/sports programs.

Today our top priority is to ensure that our students are on track to meet (or exceed) the California college and career standards. We emphasize the study skills, time management techniques, resilience and social and emotional skills that will position them to be successful in college and/or job training.

To help our students reach their potential, we need to coach parents, many of whom never had access to a post-secondary education, on how best to support their child's educational journey. Our academic staff meets one-on-one with parents, advising them on how to advocate for their child and champion his/her educational aspirations. Monthly bi-lingual parent workshops on relevant topics provide additional guidance.

Three decades of creating educational opportunities for students and families has strengthened the community and boosted the economy. Our students are not only graduating from college; many have gone on to earn graduate degrees. They have chosen careers in education, the non-profit sector, healthcare, high tech – even the NFL. EPATT alums are paying it forward and making a better world for us all.



ABOUT EAST PALO ALTO TENNIS & TUTORING

EPATT's innovative and unique program is focused on developing 21st century leaders by promoting the emotional, academic, and physical well-being of our students.

EPATT is an extended-day learning program for 120 first- through twelfth-grade students and families from socio-economically challenged neighborhoods in our community. Using a unique mix of academics, parent education, and tennis/fitness, we strive to give our students as many tools as possible to set them on a path towards life success.

ACADEMIC SUPPORT

EPATT's academic component is multi-faceted and varies depending a student's age and ability. Most kids receive between 2 to 4 hours one-to-one tutoring every week, based on their personalized learning plan. They hone their math, reading and technological literacy skills with cutting-edge online apps like Think through Math, Achieve 3000 and Lexercise. The end goal is to ensure all our kids are on track to meet or exceed the California standards for college and career readiness by high school graduation.

PARENTS AS PARTNERS

We work closely with parents to encourage them to take an active role in their child's education. We require that they attend quarterly workshops on relevant and important topics. We host community-building events like parent/child tennis night, where parents, many of whom come from different cultures and backgrounds, can get to know each other and support one another. We also connect parents to valuable resources at their child's school and in the community.

TENNIS ANYONE?

EPATT's DNA is rooted in the sport of tennis. Daily practice gives our students a chance to be active, social and learn valuable life skills like leadership, grit and teamwork. Each week, they receive 3 hours or more of tennis instruction. Students are encouraged to try out for EPATT's tournament team, which competes in USTAsponsored events around the Bay Area, as well as their high school team. Besides teaching kids a life-long sport, EPATT has also helped diversify the pool of tennis players in the Bay Area.


